The 2020 collection date for the Open Call by European Cooperation in Science and Technology (COST) will be extended by 2 weeks, with the new deadline for COST Action proposals now Friday 13 November instead of Friday 29 October.

This decision has been taken in acknowledgement of the many challenges faced by prospective applicants throughout the year due to the COVID-19 pandemic. This Open Call marks the last occasion under Horizon 2020 for prospective COST Action networks to apply for funding.

➤ **Evropska komisija je objavila razpis za evropski zeleni dogovor**

Evropska komisija je objavila razpis za evropski zeleni dogovor, ki zajema milijardo evrov sredstev za raziskovalne in inovacijske projekte, namenjene reševanju podnebne krize ter varovanju edinstvenih ekosistemov in biotske raznovrstnost Evrope. Rok za oddajo predlogov je 26. januar 2021, izbrane projekte pa naj bi se začeli izvajati jeseni 2021. Več informacij vključno z možnostjo mreženja bo na voljo v okviru digitalnih dnevov raziskav in inovacij med 22. in 24. septembrom. Člani lahko dobijo več informacij na SBRA.

Razpis za zeleni dogovor se v pomembnih vidikih razlikuje od prejšnjih razpisov programa Obzorje 2020. Usmerjen je v opazne kratkoročne do srednjeročne rezultate, ki pa bi lahko prispevali k dolgoročnim spremembam. Zajema manj ukrepov s poudarkom na hitri nadgradljivosti, razširjanju in uporabi.

Projekti, financirani v okviru tega razpisa, naj bi prinesli rezultate z oprijemljivimi koristmi na desetih področjih, ki zajemajo osem tematskih področij, ki odražajo ključna delovna področja evropskega zelenega dogovora, ter dve horizontalni področji: krepitev znanja in krepitev vloge državljanov, ki ponujata dolgoročnejšo perspektivo za doseganje sprememb, opredeljenih v evropskem zelenem dogovoru.

➤ **A new European Research Area: Commission sets new plan to support green and digital transition and EU recovery**

The European Commission adopted a Communication on a new European Research Area for Research and Innovation. Based on excellence, competitive, open and talent-driven, the new European Research Area will improve Europe's research and innovation landscape, accelerate the EU's transition towards climate neutrality and digital leadership, support its recovery from the societal and economic impact of the coronavirus crisis, and strengthen its resilience against future crises.

➤ **Vzpostavitev evropskega okvira za minimalno plačo in »evropskega bauhausa« sta med novimi pobudami Evropske komisije**

Več pobud je predstavila predsednica Evropske komisije Ursula von der Leyen v svojem prvem letnjem govoru o stanju v Evropski uniji. Predlagala je vzpostavitev evropske zdravstvene unije z vzpostavitvijo nove agencije za biomedicinske raziskave (BARDA), dvig cilja za zmanjšanje izpustov do leta 2030 na najmanj 55 odstotkov. Napovedala je vzpostavitev novega »evropskega bauhausa« oziroma prostora soustvarjanja, kjer sodelujejo arhitekti, umetniki, študenti, inženirji in oblikovalci. Petina denarja iz sklada za okrevanje bo namenila za digitalne naložbe, napovedala je zakonodajni predlog za skupen evropski okvir za minimalno plačo.

Zdravje

Nova Evropska agencija za biomedicinske raziskave (BARDA) naj bi podpirala zmogljivosti in pripravljenost EU za odzivanje na čezmjerne nevarnosti in izredne razmere, ne glede na to, ali so naravnega izvora ali namerno povzročene.

Evropski zeleni dogovor

Evropska komisija predlaga zvišanje cilja za zmanjšanje emisij do leta 2030 s 40 na najmanj 55 odstotkov. Za cilje evropskega zelenega dogovora bo porabljenih 37 odstotkov sredstev instrumenta NextGenerationEU. Industrijski podatki so zlata vredni, ko gre za razvoj novih izdelkov in storitev zato JIH je treba zavarovati za Evropo in poskrbeti, da bodo široko dostopni. EU potrebuje skupne podatkovne prostore, na primer v energetskem ali zdravstvenem sektorju, ki bi podprtli inovacijske ekosisteme, v katerih bi lahko univerze, podjetja in raziskovalci dostopali do podatkov in v zvezi z njimi sodelovali. V okviru instrumenta NextGenerationEU bo treba zgraditi evropski oblak, ki bo temeljil na projektu GaiaX.

Skupni evropski trg

Evropska komisija namerava predlagati zakonodajo, ki bi državam članicam omogočila vzpostavitev okvira za minimalne plače.

Evropa ne izkorišča v celoti naprednih tehnologij, da bi uvajala inovacije in ostala konkurenčna. Nekatere države še vedno nimajo nacionalnih strategij za digitalizacijo ali niso sprejele določenih specifičnih ukrepov, kot je vzpostavitev vozlišč za digitalne inovacije, opozarjajo revizorji Evropskega računskega sodišča. Digitalna preobrazba industrije ali digitalizacija ne pomeni le pridobivanja nove opreme in sistemov IT. Vključuje tudi razmislek o vseh vidikih poslovnega procesa ob upoštevanju možnosti, ki jih nudijo nove tehnologije.

Evropska komisija je leta 2016 začela izvajati pobudo za digitalizacijo evropske industrije, da bi spodbudila digitalizacijo podjetij. Revizorji so obiskali štiri države članice (Nemčijo, Madžarsko, Poljsko in Portugalsko), da bi na terenu iz prve roke zbrali podatke o njenem uresničevanju. Na tej podlagi ugotavljajo, da je digitalizacija industrije EU v zadnjih letih napredovala, vendar z različno hitrostjo glede na državo, regijo in sektor. Obstajajo tudi velike razlike med velikimi podjetji ter malimi in srednjimi podjetji.

Revizorji so v poročilu navedli več priporočil, pri katerih so upoštevali tudi predlagani novi program za digitalno Evropo za obdobje 2021–2027. Njihova priporočila se nanašajo na pomoč državam članicam pri opredelitvi njihovih vrzeli v financiranju in informiranje o razpoložljivih sredstvih EU, na izboljšanje spremeljanja pobude za digitalizacijo evropske industrije z določitvijo ustreznih kazalnikov rezultatov in sledenjem porabe, na opredelitev, uskladitev in sprejetje okvira za mrežo evropskih vozlišč za digitalne

inovacije, ki bi zajemala vse evropske regije, ter na sprejetje nadaljnjih ukrepov za podporo pri doseganju ustreznih ravni širokopasovne povezljivosti.
